



## ACCIDENTAL DAMAGE

In the event of accidental damage to the violin, we will make all necessary repairs at no additional charge, with the following exceptions:

- Strings will not be replaced free of charge. However, we will provide replacement strings at a 10% discount from our regularly published prices. Note: We recommend caution when tuning strings – over-tightening will cause breakage.
- We will not replace lost or stolen instruments, nor will we repair or replace instruments damaged by fire, flood, or natural disaster. To insure against these eventualities, we recommend adding a rider to your renters or homeowners insurance policy.
- If your violin is repeatedly damaged, or if, in our sole discretion, we feel that the damage is caused by abuse or neglect, we reserve the right not to issue a new rental instrument. In such circumstance, we will allow 90 days for you to return the damaged instrument, with all accessories, and apply any accumulated rental credit toward the purchase of a comparable instrument.
- Note: Accessories, including bow, case, rosin, and shoulder rest, may be purchased at a 10% discount from our regularly published prices. These items will not be replaced free of charge, except in the case of manufacturer defect.

*Under Pennsylvania state law, we are required to inform you that you are not obligated to purchase an insurance policy or damage liability waiver for your instrument from J.S. Fisher Violins or any party controlled by J.S. Fisher Violins. Note: We do not sell insurance or damage liability waivers.*

## TRADING SIZES

You may upgrade to a larger size, when needed, with no loss of credit. There is no charge to upgrade sizes, though a shipping fee may apply (see below).

## SHIPPING FEES

We are usually able to deliver instruments personally to our customers at no charge. However, this service is not guaranteed. Should we find it necessary to send your instrument by mail, a \$25.00 shipping fee will apply.

## RENTAL CREDIT

Rental credit is calculated by multiplying the number of payments made by the Rental Fee amount. The quarterly Rental Fee amount for this instrument is \$39.00.

## PURCHASING THE INSTRUMENT

Upon your 23<sup>rd</sup> payment of \$49.29, this agreement will terminate and the instrument will become your property. If a more expensive instrument is desired, rental credit may be applied toward the purchase price at this time or may be transferred to our Advanced Instrument Rental Program.

## EARLY PURCHASE OPTION

You may purchase the instrument at any time. The total due will be the Instrument Cash Price of \$897.00, less Rental Credit (calculated above), plus 6% Pennsylvania sales tax.

## RETURNING THE INSTRUMENT

You may terminate this agreement at any time by returning the instrument to J.S. Fisher Violins. Upon return of the instrument, all rental credit will be lost. Rental credit may not be held or transferred to any other party.

## PAYMENT METHOD

You agree to provide us with a valid credit card and to keep us informed of any change in your credit card information. You authorize J.S. Fisher Violins to make all charges, as detailed in this agreement, to your credit card. Failure to maintain a working credit card for this purpose will constitute a failure to make payment.

## LATE PAYMENTS & RIGHT TO REINSTATE

**Should you fail to make timely payments, as detailed, above, all rental credit will be forfeit and J.S Fisher Violins may repossess the instrument. You may reinstate this agreement by paying all past due charges within five days. Should you voluntarily return the instrument, you have the right to reinstate this agreement within 30 days if your accumulated rental credit is less than \$755.78, or within 90 days if your accumulated rental credit is greater than or equal to \$755.78.**

## MANUFACTURER'S WARRANTY

The instrument comes with no warranty from the manufacturer. Any warranty that did exist would be passed to you upon gaining ownership of the instrument, if allowed by the terms of said warranty.

## NOTICE

**You are renting the instrument. You will not own it until you make all of the regularly scheduled payments or you use the early purchase option. You do not have the right to keep the property if you do not make required payments or do not use the early purchase option. If you miss a payment, we can repossess the property, but you may have the right to the return of the same or similar property. Please read the full agreement for an explanation of your rights.**
